License Requirement - At the time of Bid and pursuant to the requirements of Section 10-3 of the Code of Miami-Dade County, Florida and this RPQ and Contract Documents, the Bidder must hold a valid, current, and active State and/or Miami-Dade County contractor's license from the County's Construction Trades Qualifying Board, which is consistent with the requirements of the Scope of Work. Specialty contractors shall subcontract with a qualified contractor, as required by chapter 10, for any work, which is incidental to their specialty but is specified in the aforementioned Code as being work other than that of the certified specialty.

SCOPE OF WORK:

The licensing requirement of the Prime Contractor for this project is State of Florida General Contractor or General Engineering Contractor License as applicable to Chapter 10 of the Miami-Dade County Code.

The Contractor shall furnish all materials, labor, services, supervision, tools, equipment, and all other items necessary for the construction of concrete runway foundations and tie-downs for future passenger boarding bridges as well as to construct new mooring bollards and hardware for cruise ships at Miami-Dade County Seaport Department.

The project is comprised of, but not limited to: demolition and removal of existing asphalt pavement and excavation for the runway and bollard foundations; construction of concrete grade beam on auger cast piles runways, with tie-downs; construction of concrete bollard foundations and hardware with auger cast piles; patch and repair of existing asphalt pavement damaged by construction; and any supportive ancillary tasks to successfully complete all phases of the project.

The Contractor must meet the below requirements:

- Contractor (Prime or Sub contractor) performing the Work of this Project shall have a minimum experience of at least three (3) projects of similar scope, involving the placement of concrete structural runways/foundations on piles in excess of 18 inches deep, completed during the past ten (10) years; one (1) of these three (3) projects completed within the past five (5) years under the firm's current business name. The experience must be demonstrated by the individual of the Prime or Sub contractor that will have direct or substantial involvement in the supervisory capacity at the Project Manager level or above. As a condition of award, the selected contractor shall submit individual's name(s), list of past projects, contact information, and references.
- Auger Cast Piling Installer: Minimum of five (5) years of past successful experience in the installation of auger cast grout piles. Submit three (3) projects which include the installation and testing of tension piles.
- Mooring Bollard Installer: Minimum of five (5) years of past successful experience in forming and placement of equipment foundations. Submit three (3) projects demonstrating the installation of bollard or equipment foundations involving monolithic pour of 36 inches or greater.

All work shall be performed in accordance with the Contract Documents.
