Subject:

Material Breaches in County Contracting

On June 2, 2009 the Board of County Commissioners (Board) adopted Resolution R-749-09 (attached) which requires that the County Mayor or designee report to the Board instances where the County Mayor or designee waives a material breach of contract or allows a vendor, contractor or consultant more than 30 days to cure a material breach of a contract. The reporting requirement applies to contracts awarded by the Board and reports must be made to the Board within five business days. Department directors must effectively manage the performance of vendors, contractors or consultants on county contracts. Any performance deficiency must be identified and addressed expeditiously so as to avoid any escalation in terms of meeting contractual obligations.

A material breach of contract is a substantial breach of a significant term or terms of a contract that excuses the non-breaching party from further performance under the contract and gives the non-breaching party the right to recover damages. In the event that performance deficits lead to a material breach of contract, departments should contact the Department of Procurement Management for consultation. To date, we are not aware of any authorized waiver of a breach of contract. In addition, in no instance shall a material breach of contract be waived without careful evaluation from the administration. Once reviewed by the administration, any settlement of such breach will be brought to the Board for consideration.

RESOLUTION DIRECTING THE COUNTY MAYOR OR HIS DESIGNEE TO NOTIFY THE BOARD OF COUNTY COMMISSIONERS WHEN THE COUNTY WAIVES ANY MATERIAL BREACH OF A CONTRACT OR EXTENDS A CONTRACT CURE PERIOD BEYOND 30 DAYS

WHEREAS, the Miami-Dade County Home Rule Charter provides that the Board of County Commissioners shall approve contracts with the County; and

WHEREAS, the Board of County Commissioners has delegated the administration of contracts to the County Mayor or his designee; and

WHEREAS, the County Mayor or his designee exercises discretion in resolving material breaches under the provisions of the contract and the authority of the Board pursuant to such delegation; and

WHEREAS, timely notice to the Board of County Commissioners of the County Mayor or his designee's exercise of delegated authority will allow the Board of County Commissioners to provide further policy directives on contracts on an as needed basis,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, this Board directs the County Mayor or his designee to provide notice to this Board, within 5 business days, of when the County Mayor or his designee either waives a material breach of a contract awarded by the Board or allows a vendor more than thirty (30) days to cure a material breach of a contract awarded by the Board.
