(NANA) to extend the Agreement for an additional six months in an amount not to exceed \$50,000.00, in substantially the form attached hereto as Exhibit 1 and incorporated herein by reference. This Board further authorizes the Executive Director or Executive Director's designee to exercise all provisions contained therein.
