

## **Unavailability of SBE/Cons Firm Due to Competitiveness SMALL BUSINESS ENTERPRISE - CONSTRUCTION PROGRAM**

Pursuant to Implementing Order 3-22, bidders may establish a SBE/Cons firm as unavailable if its bid is not reasonably competitive with comparable bids of non-SBE/Cons firm for the same scope of work. To establish a SBE/Cons firm as unavailable, the prime bidder must furnish SBD with copies of all bids received from both SBE/Cons and non-SBE/Cons firms, for each specific scope of work for which they are claiming that the bid is not reasonably competitive (over 25%). A SBE/Cons firm's bid will be considered reasonably competitive if its bid for the same scope of work is within 25% of the bid from a comparably sized non-SBE/Cons firm. SBD Forms 305A and 305B must be completed and submitted by the Prime Contractor to the Contracting Officer on the bid submission due date.
