# Miami-Dade County Small Business Enterprise (SBE) – Goods & Services (G&S) Program

# AWARDED CONTRACTS

There were 86 G&S contracts approved for award totaling \$214,675,119.

• 57 contracts were not eligible for SBE measures due to being a sole source/bid waiver/legacy/revenuegenerating contract, accessing of a state contract, or funding source.

# CONTRACTS AVAILABLE FOR SMALL BUSINESS PARTICIPATION

There were 29 contracts available for SBE measures with total award amount being \$142,622,655.

- 1 contract had a SBE Measure (goal) of 20% for \$3,308,400
- 27 contracts were advertised as a SBE Bid Preference or Selection Factor. Of the contracts awarded during this period, SBE-G&S firms are participating as Prime and/or subcontractors (with or without measures) for a dollar value of \$7,154,302 or 5.02%.

In this period, payments to all vendors on Goods & Services contracts totaled \$522,379,490.

• Under existing contracts and pre-qualification pools, SBE-G&S firms were paid a total of \$52,307,942, or 10.01% of total payments.
