Subject: Notice of a Professional Services Agreement for the PROS Full Services PSA – Coastal Parks North, ISD Project No. A15-PROS-01 GOB, PROS Contract No. 999999-15-005. Recommendation for Goals

The Parks, Recreation and Open Spaces Department (PROS) requests that you review the attached recommendation for goals pursuant to the Community Business Enterprise (CBE) Program. This project is funded through the General Obligation Bond (GOB) Program.

BACKGROUND

PROS operates more than 260 parks and manages more than 12,000 acres of land; and has up to \$113,000,000 of capital improvement funding through the GOB Program to spend over the next seven years on new improvements and renovations throughout the park system; with more than \$30,000,000 allocated to parks located along the coastal boundary of Miami-Dade County. There are other potential sources of funding that PROS may receive to increase the capital budget.

PROJECT DESCRIPTION

For the proposed improvements and renovations PROS desires to implement designs that are functional, aesthetically pleasing and innovative while remaining responsive to the unique history, character and context of the area, and that will stand up to the test of time.

The Professional Services Agreement (PSA) for consultant will be used to implement improvements and renovations mentioned above. The selected consultant will be required to perform planning, architectural design, engineering, landscape architecture design, surveying, mapping, scheduling, estimating, construction administration, construction engineering & inspections and construction management services for new construction, renovations and restoration projects located at multiple parks along South Florida's eastern coastline between the North County Line and SW Kendall Drive in Miami-Dade County (Coastal Parks North Region).

The selected consultant shall also be responsible for incorporating LEED approved green building principles. Pursuant to County Implementing Order No. 8-8 "Sustainable Building Program," all new construction projects shall be required to attain "Silver" or higher certification level under the LEED-NC Rating System. The participation of experienced LEED®AP professionals is required in order to achieve optimum results in the application of said practices.

The selected consultant must have sufficient resources to provide the requested professional services for up to three design projects concurrently. PROS reserves the right to assign any or none of the work at the Coastal Parks North Region to the selected consultant.

The selected consultant will be responsible for the review and compliance of the General Facilities (GF), Master Plan, and Guidelines for each park design project. If the project needs variances to the code, the selected consultant shall attend all hearings, complete all applications, prepare plans, as well as provide any resources and/or additional information as required by Miami-Dade County to obtain said variance.

EXPERIENCE AND QUALIFICATIONS

The prime consultant must hold technical certification categories 14.00 (Architecture), 18.00 (Architectural Construction Management), and 22.00 (ADA Title II Consultant), and hold active professional registration status in the Florida state Board of Architecture.

The prime consultant responding to the solicitation must have ten years of experience in park planning and design; and have been responsible or involved in a primary role for the design of at least two parks, and/or community gathering places located in a coastal zone that included marinas, beaches or public access to a large body of water.

The project manager assigned by the prime consultant must have at least ten years of experience in architectural design. A background in landscape architectural design, a general knowledge of engineering design and historic preservation is desired.

PROS has evaluated this project and recommends establishing a **10% CBE goal** for the Professional Agreement (Technical Categories 12.00 with 5% and 13.00 with 5% respectively). If additional information is required, please contact Adelfa Martinez at (305) 755-7815.
