**Description of Project/Bid:** The work includes all design and construction services necessary to construct improvements along NW 84th Avenue between NW 58th Street and NW 74th Street (approximately one mile). Elements of design shall include, but are not limited to, roadway reconstruction, milling and resurfacing, driveway harmonization, a proposed stormwater system consisting of continuous interconnected exfiltration trench, 6-foot-wide continuous sidewalks, curb and gutter, pavement markings, signage, signalization (Pedestrian/Traffic), utility relocations and tree removal/relocation within the 70' Right-of-Way. The typical section consists of four 11-foot travel lanes, a 10-foot-wide center two-way left turn lane, sidewalk in both directions and curb and gutter throughout. Work also includes but is not limited to providing all geotechnical, survey, and design services necessary to produce the required construction documents, engineering plans, traffic control and maintenance of traffic plans to detour traffic; project permitting; public involvement plan; and all project coordination.
