To establish a professional agreement to conduct monthly environmental inspections, oversight & sampling of the following facilities within MDAD Airport Properties (Landside & Airside) for compliance with Federal & Local regulatory requirements: underground & aboveground fuel storage tanks & associated monitoring wells at MIA, aboveground tuel storage tanks at MIA, Opa-Locka Airport, Homestead General Aviation Airport, Kendall-Tamiami Airport, Dade Collier Training & Transition Airport. This agreement will also include drinking water sampling, sewage pump station elapsed time meter readings, orphan drum & hazardous inspections at MIA. Any other inspection/investigation or testing/sampling required will be for compliance so that Airport operations are not impacted.
