Reasons for Recommendation

E15-WASD-19 will establish a Non-Exclusive Professional Service Agreement (PSA) which will retain one (1) qualified consultant. The duration of this PSA is eight (8) years. Maximum compensation is \$10,000,000.00, plus a ten percent (10%) contingency allowance. No minimum amount of work or compensation will be assured to the retained Consultant.

SMALL BUSINESS ENTERPRISE - ARCHITECTURAL & ENGINEERING (SBE/AE)

An analysis of the factors contained in the project package, as well as the factors contained in Section V. C. of Implementing Order 3-32 and the responses of certified SBE/AE firms to the Verification of Availability to Propose process indicates that a 24% SBE/AE Sub-consultant Goal is appropriate for this contract. Verification of Availability to Propose letters were sent to the SBE/AE firms certified in the technical categories below; however, three (3) or more firms did not respond to Verification of Availability process as being able to satisfy the contract's requirements.

An analysis of Implementing Order 3-41 & Ordinance 14-41, as well as the project package indicates a 3,00% SBE/GS Subcontractor Goal is appropriate to the SBE/GS portion of this contract.
