Description of Project/Bid: DTPW has a need to establish a contract to provide services for the Metromover Comprehensive Wayside System Overhaul project. The Metromover Comprehensive System Replacement Project, also identified as Metromover Rejuvenation Project, includes the full replacement of the existing train control equipment (on-board, wayside and at central control) with an overlay capable Communications-Based Train Control System that includes a new Master Clock System, a precision clock that distributes timing signals to synchronize slave clocks as part of a clock network. In addition, the Metromover Rejuvenation Project includes replacement and refurbishment of other train control related equipment, Power Distribution System related equipment, the inspection and restoration to service conditions of vehicles #38 and #41, and the installation of physical barriers at the Maintenance and Storage Facility pseudo stations cliff-side.
