
Reasons for Recommendation
<p>An analysis of the trade required for this contract, as well as an analysis of the availability of SBE-Construction firms revealed insufficient availability. A similar contract (MDAD 718-R) was bid through the MCC 7040 Contract, however, only one (1) bid was received which was deemed non-responsive.</p> <p>Verification of Availability to Bid Letters were also sent to SBE-Construction firms, and a poll was conducted - However; none of them were able to meet the project's requirements.
