Description of Project/Bid: The project consists of roadway and traffic operational improvements. The improvements include, but are not limited to, new road construction, widening, resurfacing, drainage, curb and gutter, sidewalks, signalization, pavement markings and signage, lighting, bicycle lanes, and WASD utility improvements (includes new water main, fire hydrants, new water services and reconnections of existing stub outs).

Reasons for Recommendation

This is a re-advertisement of Project 20200197 that had an original cost estimate of \$9,924,188.37, a SBE-Con goal of 9.15% and a SBE-Service goal of 0.52%; DTPW changed the estimated cost to \$12,719,731.81 to adjust to current market prices.

SMALL BUSINESS ENTERPRISE- CONSTRUCTION (SBE-Con)

SBD reviewed this project pursuant to Implementing Order 3-22 for a SBE-Con measure. Project information analyzed included the project's scope of services, estimated project cost, minimum requirements/qualifications and funding source. These indicate a 8.83% SBE-Con subcontractor goal is appropriate for this contract in the following trades: Highway, Street and Bridge Construction (Concrete curbs and sidewalk) – 7.24% and Painting and Wall Covering Contractors (Pavement Marking and Signage) – 1.59%. This project had an original SBE-Con subcontractor goal of 9.15%, however the change on the new cost estimate impacted the original SBE-Con subcontractor goal to an 8.83%.

Miami Dade County Highway Construction Responsible Wages apply to this contract.

SMALL BUSINESS ENTERPRISE - SERVICES (SBE-Services)

SBD reviewed this project pursuant to Implementing Order 3-41 & Ordinance 16-109 for a SBE-G or SBE-S measure. Project information analyzed included the project's scope of services, estimated project cost, minimum requirements/qualifications and funding source; these indicate a 0.62% SBE-Service subcontractor goal is appropriate to the Goods & Services portion of this contract in Commodities #98852 (Landscaping) and #96888 (Tree and Shrub Removal Services).
