Reasons for Recommendation

SMALL BUSINESS ENTERPRISE – CONSTRUCTION (SBE-Con)

An analysis of the factors contained in the project package, as well as the factors contained in Section VI.C. of Implementing Order 3-22 indicates that a 23.31% Small Business Enterprise – Construction (SBE-Con) Subcontractor Goal is appropriate for this contract in the following trades: Highway, Street and Bridge Construction (Asphalt, Erosion Control, Concrete Curbs and Sidewalks & Striping) – 6.49%, Site Preparation Contractors (Excavation/Grading work) – 7.00%, All Other Specialty Trade Contractors (Fencing) – 1.13%, Plumbing, Heating and Air-Conditioning Contractors (Irrigation) – 3.50% and Electrical Contractors and Other Wiring Installation Contractors (Electrical work) – 5.19%.

An attempt was made to assign this project a Set-Aside measure; however, only two (2) firms responded to the Verification of Availability to Bid process as being able to meet the project's requirements.
