END-OF-LIFE REPLACEMENT: Re-Laminate Loge Cabinet Doors

APPROXIMATE PROJECT COST: ██████████

SCOPE OF WORK:

- Furnish and install all labor (including field measurements), materials, equipment and tools necessary to complete the following:
 - Re-laminate existing loge cabinet doors in fifty-two (52) locations.
 - Replace all doors and appliance panels with new pre-finished reconstituted oak veneer doors per approved sample.
 - **Veneer:** Reconstituted Rift Cut White Oak
 - **Finish:** 2 part polyurethane
 - Replace all damaged wood edge band.
 - Replace wood veneer at all finished ends and backs.
 - Replace damaged hardware and install new pulls.
 - Existing door hinges and trash pullouts to be reused.
 - Existing stone countertops to remain "as is."
 - The interiors of the new doors will be matching oak veneer.

TIMELINE:

- The following is the maximum time allotted upon approval of vendor: (2) weeks for proposal and shop drawings, (4) weeks for fabrication, and (3) weeks for installation.
- Vendor must submit a schedule of anticipated work days to Vice President of Operations or his designee for approval and must account for events as follows:
 - Event Days – crews allowed onsite from 7am – 3pm when the event occurs in the evening;
 - Crews will not be allowed onsite when an event occurs in the morning and/or afternoon (e.g., ██████████ matinees and school shows); and
 - Non-Event Days – crews allowed onsite for extended hours as needed.

WARRANTY:

- Vendor must be able to provide a 3 year warranty on all materials and labor.

RESTRICTIONS:

- Millwork vendors must design/create shop drawings of proposed millwork package to be submitted at time of proposal. Upon award, millwork vendor must have samples and final millwork shop drawings approved by client within 5 working days.
- The vendor must be able to demonstrate the ability to complete their entire scope of work based on occupational experience with projects of similar size and scope. Proof of completed projects must be submitted at time of proposal.

RFI #1111 – Re-Laminate Loge Cabinet Doors

- Vendor must provide and identify anticipated project manager/supervisor for duration of installation.

INSURANCE:

- Vendor shall purchase and maintain during the entire project and for two years after project completion insurance with the minimum limits and coverage shown below from insurance companies acceptable to Basketball Properties, Ltd. (“BPL”). BPL has the right to reject unacceptable insurance carriers.

- Vendor shall carry standard ISO General Liability coverage, written on an occurrence basis including Completed Operations. Coverages on an occurrence basis shall be maintained without interruption from date of commencement of the Vendor’s Work until date of final payment or date coverage is required to be maintained after final payment to the Vendor, whichever is later. The coverage must be endorsed to name Basketball Properties, Ltd., City of Miami, and Miami-Dade County as additional insureds on a primary and non-contributory basis.
