The Department of Transportation and Public Works (DTPW) is forwarding this memorandum to Miami-Dade County Internal Services Department's Division of Small Business Development for informational purposes regarding the referenced project. As a result of DTPW'S Office of Civil Rights (OCR) analysis of the workload based on the anticipated project's scope of work and cost estimate, a 18% Disadvantaged Business Enterprise goal has been assigned by OCR for this project.

The funding source for the project is Federal Transit Administration, Florida Department of Transportation, and People's Transportation Plan Bond Program. The construction cost estimate for this project is \$10,045,675, which includes a 5% contingency.

Scope of Services

DTPW requires construction services for the SR 836 Express Bus Services - Park and Ride/Bus Terminal (Tamiami Station) located on the southwest quadrant of SW 8 Street and SW 147 Avenue. The work includes, but is not limited to: furnishing all supervision, labor, materials, equipment, tools, services and incidentals necessary for the construction of the Park and Ride/Bus Terminal (Tamiami Station) facility and associated roadway improvements.

In addition, the Contractor must meet the below requirements:

- Miami-Dade County Contractor's Certification is required in one of the following categories: General Building Contractor, or other categories as applicable to Chapter 10 of the Miami-Dade County Code, or State of Florida General Contractor's License.
- Bidders must be able to demonstrate, through prior experience, the ability to construct projects of similar size and scope, as described in the project's Summary of Work. Bidders shall provide documentation that demonstrates their ability to satisfy all of the minimum qualification requirements.

Pursuant to 49 Code of Federal Regulations (CFR) Part 26, the Department of Transportation and Public Works (DTPW) has a need to establish construction services for the SR 836 Express Bus Services - Park and Ride/Bus Terminal (Tamiami Station) located on the southwest quadrant of SW 8 Street and SW 147 Avenue. The work includes, but is not limited to: furnishing all supervision, labor, materials, equipment, tools, services and incidentals necessary for the construction of the Tamiami Station Park-and-Ride/Bus Terminal facility and associated roadway improvements. This segment is funded in part with federal and state funds and is subject to third party contracting requirements.

RECOMMENDATION

After a review of the scope of work, and in keeping with 49 CFR Part 26- this office recognizes that this project presents a premium opportunity for certified DBE's who by reason of their certification are ready, willing, and able to provide and assist with the services delineated in the scope of work. Therefore, an eighteen percent (18%) DBE goal is assessed to the overall project.
