### RECOMMENDATION

The Department's Capital Improvements staff completed the review of the subject RPQ in accordance with the applicable provisions of Implementing Order 3-22 and recommends a Small Business Enterprise - Construction (SBE-CONST) measure of 20% as requested by the DTPW Director and CEO. A Community Workforce Program (CWP) goal, if applicable, is to be determined by Small Business Development.

### **SCOPE OF WORK**

Work under this Contract includes furnishing of all supervision, labor, materials, tools, equipment and performing all operations required for the demolition of MLK Parking Garage, including footers removal, preparation of materials for disposal, loading and transportation of materials for recycling/disposal, and disposal costs. The garage is approximately 265,000 SF of three-story parking building, inclusive of partial demolition of the south canopy over the roadway, as close as possible to the parking garage, and partial demolition of the west canopy to the east side of the roadway as close as possible to the parking garage.

Work also includes demolition notification to the National Emission Standards for Hazardous Air Pollutants (NESHAPS), dust control, removal & disposal of electrical work inclusive of bulbs/ballast, removal & disposal of all mechanical system, inclusive of elevator hydraulic oil, shafts, and tanks. All utilities inclusive of water and sewer must be removed and properly capped. Existing generator to be removed and disposed of.

Contractor to provide 24/7 security guard services during the entire demolition time, Maintenance of Traffic, Stormwater Assessment and Protection Program (SWAPP), including truck wash. Contractor also must furnish & install a perimeter fence with two (2) gates, wind screen and silt fence while the demolition takes place. At the end of the demolition, contractor must leave the fence to secure the perimeter, silk barrier should be removed after demolition has been completed. Fence must be free of damages, and the two (2) gates should be functional and be equipped with locking mechanism for security purposes. Work also

includes tree protection and tree removal. Contractor to provide structural fill-material, including compaction and final grading.
