Tier 1 projects will encompass large scale, complex projects to include interior and exterior illuminated and non-illuminated directional signage, dynamic signage, roadway signage, work requiring structural and electrical engineering and installations. Firms in this category will be required electrical licensure, engineering capability, bonding for work orders in excess of \$200,000.00 and insurance, along with minimum qualifications listed in the RFQ.
