SBD is conducting a survey of Electrical Contractors to perform **Switch Logic Cabinet Overhaul Metromover**. In order to establish sufficient availability of contractors under **MCC 7040 Contract** for **Miami Dade TRANSIT Department**. **If you are interested in participating on this contract, and meet the requirements, please reply to this email IMMEDIATELY; Thursday, August 6 at 12:00 Noon the latest.**

**SCOPE:** The scope of work for this project is highly specialized work involving disconnection and equipment removal, furnishing, installation, and testing of seven new switch logic control cabinets. Temporary removal of portions of platform grating, handrail and/or walkway support steel will be required at some locations to remove and install the described equipment.

Due to the special operational conditions the contractors shall be required to:

- Contractor must be able to provide a list and brief description of at least 3 completed projects of similar scope of work, size and complexity.
- Submit the **Performance & Payment bond in the amount of the entire contract allocation of \$3,235,700.00**
- Comply with the **INDEMNIFICATION AND INSURANCE** requirements as follow:
- The Contractor shall furnish to Miami Dade Transit, ATT: Ivonne Andres, 701 N.W. 1st Court, 15th Floor, Certificate(s) of Insurance which indicate that insurance coverage has been obtained which meets the requirements as outlined below:
  - A. Worker's Compensation Insurance for all employees of the Contractor as required by Florida Statute 440.
  - B. Commercial General Liability Insurance on a comprehensive basis, **in an amount not less than \$1,000,000** combined single limit per occurrence for bodily injury and property damage. Miami-Dade County must be shown as an additional insured with respect to this coverage.
  - C. Automobile Liability Insurance covering all owned, non-owned and hired vehicles used in connection with the work, **in an amount not less than \$500,000** combined single limit per occurrence for bodily injury and property damage.

All insurance policies required above shall be issued by companies authorized to do business under the laws of the State of Florida, with the following qualifications:

The company must be rated **no less than "A-"** as to management, and **no less than "Class VII"** as to financial strength by Best's Insurance Guide, published by A.M. Best Company, Oldwick, New Jersey, or its equivalent, subject to the approval of the County Risk Management Division.

The company must hold a valid Florida Certificate of Authority as shown in the latest "List of All Insurance Companies Authorized or Approved to Do Business in Florida" issued by the State of Florida Office of Insurance Regulation.
