Description of Project/Bid: This is an Ocean Outfall project that consists of furnishing all labor, materials and equipment necessary for the construction of a new chlorine contact chamber (CCC 10); construction of wellheads for 3 new injection wells (drilled by others); construction of a 72-inch pipeline to serve as an interconnect between the north and south sides of the effluent loop including a concrete vault for a flowmeter; construction of a 108-inch prestressed concrete cylinder pipe from the filter effluent flume to the CCCs influent pipe near CCC 9; associated yard piping; and overall site civil grading and drainage improvements at the South District Wastewater Treatment Plant owned by the Miami-Dade Water and Sewer Department (WASD) and located at 23300 SW 88th Avenue Miami, FL 33032.
