The project consists of furnishing all materials, labor, and equipment, including necessary to construct the proposed 2,500 LF of water mains, 5,882 LF of gravity sewers, and 1,379 LF of force main, including, but not limited to, mobilization; site preparation and clearing and grubbing as necessary; furnish and install new water mains, gravity sewers, and force main; furnish and install connections to the existing water mains and force main; stub-outs for connections to the future Pump Station; site restoration; testing; and other appurtenant and miscellaneous items and work for a complete, satisfactory and functional installation for this force main as shown on the contract drawings and as specified herein. Water mains, gravity sewers, and force mains will be constructed in accordance with MD-WASD Design Standards.
