This License Agreement is between you and Miami-Dade County through its Department of Transportation and Public Works ("DTPW" or "Transit Agency") only, and only pertains to your use of the Application. The terms and conditions governing your use of the EASY Pay Miami Application and the fare policies of DTPW can be found at the DTPW Transit Store.

## **Application Use.**

DTPW grants you the right to use this Application only for your personal use on a mobile product that you own or control and as permitted by any terms of use required by the party providing the app store from which you have downloaded this Application. You may not modify, copy, publish, license, sell, or otherwise commercialize this Application or any information or software associated with this Application. You may not rent, lease or otherwise transfer rights to this Application. You may not use this Application in any manner that could impair any Transit Agency's site(s) in any way or interfere with any party's use or enjoyment of any Transit Agency's site(s), including any use of this Application that imposes or may impose an unreasonable or disproportionately large load on the Transit Agency's infrastructure. You must use the Application in compliance with all applicable laws. You must comply with applicable third-party terms of agreement when using this Application (e.g. your wireless data service agreement). Your right to use this Application is subject to immediate termination if you violate any provision of this License Agreement, the EASY Pay Miami User Agreement Terms and Conditions for Transit or any of the Transit Agency's rules, regulations, terms and conditions.

## **EASY Pay Miami Account.**

To purchase a digital Transit Pass, you must have an account. You can create a new account or simply log in using your Miami-Dade County Transit Store account username and password.

## **Proof of Fare Payment.**

Tickets purchased through this Application are stored on your phone. It is your responsibility to use a charged and properly operating mobile device with Internet connectivity to access and use this Application. You are solely responsible for the proper functioning of your mobile phone to show proof of payment. You agree to comply with <a href="Chapter 30B">Chapter 30B</a>, of the Code of Miami-Dade County, Florida, including but not limited to Section 30B-4(15), and fully cooperate with Miami-Dade County Police Officers and/or Department of Transportation and Public Works (DTPW) officials upon request to exhibit proof of digital fare payment while accessing or riding DTPW facilities or vehicles.

## Refunds/Compensation.

All sales are final. Refunds are not issued for unused trips on an activated Pass. No compensation will be given for delays outside of our control, including extreme weather, emergency investigations, pedestrian incidents, road/highway conditions, track obstructions, and on-board emergencies.
