The list below contains zoning items which may be of interest to your immediate neighborhood.

**1. QUANTUM VENTURES LLC (05-375)**

Location: Between SW 157 Avenue & SW 149 Avenue, and between SW 172 Terrace & SW 178 Terrace, Miami-Dade County, Florida (120 Gross Acres).

The applicant is requesting zone changes from agricultural district, single-family modified estate district, single-family one acre estate district, and single-family residential district to town house district, on a portion of the property, and other zone changes from agricultural district, single-family modified estate district, and single-family residential district to single-family modified residential district (RU-1Ma) on another portion of the property. Also requesting to permit accompanying request(s), on this site.

**2. ANDREW AND GINA HARVEY-READ (06-250)**

Location: 12855 SW 116 Street, Miami-Dade County, Florida (75' X 100').

The applicants are requesting to permit a covered terrace addition to a single-family residence, an existing residence and a metal shed setbacks to be less than required from property lines, and to permit the metal shed to have zero square footage from the primary residence where space is required, on this site.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications. Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
