The list below contains zoning items which may be of interest to your immediate neighborhood.

1. ARCHBISHOP JOHN C. FAVALORA (07-343)

Location: The northeast corner of SW 57 Avenue and SW 84 Street, Miami-Dade County, Florida (13.91 Acres)

The applicant is requesting a modification of a condition of a previous resolution to allow the applicant to submit a new site plan showing less property for a previously approved site plan, to permit a building setback less than required from property lines and with a lot coverage greater than permitted. Also requesting accompanying requests, on this site.

2. ARCHBISHOP JOHN C. FAVALORA (08-160)

Location: The northwest corner of SW 54 Avenue and SW 84 Street, Miami-Dade County, Florida (15.43 Acres)

The applicant is requesting a special exception to permit the expansion of an existing school use onto additional property to the west, to permit an outdoor recreation area smaller than required, to permit a proposed gymnasium/fine arts building setbacks to be less than required from property lines, with a greater height than permitted, and with 3-stories where only two are allowed. Also requesting to permit accompanying requests, on this site.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
