THE LIST BELOW CONTAINS ZONING ITEMS WHICH MAY BE OF INTEREST TO YOUR IMMEDIATE NEIGHBORHOOD.

1. FERNANDO & STACY DONAYRE (09-59)

Location: 14100 SW 92 Avenue, Miami-Dade County, Florida (20,300 sq. ft.)

The applicants are requesting a modification of a condition of a previous resolution to allow the applicant to submit revised plans showing modifications to the previously approved lake slope and a dock structure. Also the applicant is requesting to permit a single-family residence with a greater lot coverage than permitted, to permit the residence, boat ramp, canopy, decorative fountain, shower and barbecue setbacks to be less than required from property lines. Additionally, the applicant is requesting to permit accompanying requests, on this site.

2. WRC PROPERTIES, INC. (09-143)

Location: Lying north of SW 88 Street (North Kendall Drive), between the homestead extension of Florida's Turnpike and SW 117 Avenue, Miami-Dade County, Florida. (87 Acres)

The applicant is requesting to permit an individual tenant in a shopping center to have 3 wall signs where 2 signs are permitted for each tenant, on this site.

3. LKS ASSOCIATES L.P. (09-144)

Location: 6801 SW 117 Avenue, Miami-Dade County, Florida (16 Acres)

The applicants is requesting to permit additional detached signs than permitted, and previously approved, on this site.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
