1. **VICTOR & NERY LOPEZ (06-126)**

Location: 15000 SW 105 Avenue, Miami-Dade County, Florida (173' X 98')

The applicants are requesting to permit a carport addition to a single-family residence and an accessory building setbacks to be less than required from property lines, and to permit the accessory building to be spaced less than required from the principal residence, on this site.

2. **ORLYN NUNEZ (06-246)**

Location: Lying west of SW 209 Avenue, approximately 495' south of SW 152 Street, Miami-Dade County, Florida (2.5 Acres)

The applicant is requesting to permit a parcel of land for a single-family residence with less lot area and less lot frontage than required, on this site.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications. Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
