## 1. EUREKA HOLDINGS, LLC F/K/A: SWEET HOME BAPTIST CHURCH, INC. (06-163)

Location: The southwest corner of SW 180 Street and SW 107 Avenue, Miami-Dade County, Florida (11.73 Gross Acres).

The applicant is appealing the decision of Community Zoning Appeals Board #14, which denied without prejudice the following:

The applicant is requesting a zone change from agricultural district to minimum apartment house district, on this site.

## 2. CRAIG ARMSTRONG (07-32)

Location: 12225-55 SW 128 Street, Miami-Dade County, Florida (9.31 Acres).

The applicant is requesting an appeal of an administrative decision alleging that the Director erred in a determination that approved plans resulting in the issuance of permit #2005-107355. The above request is to require concrete dumpster structures to comply with building setback requirements and to require the relocation of the dumpster structures from within the required 10' wide greenbelt along the rear (North) property line, on this site.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
