**1. MERRINECK ESTATES, LLC & MEDICO
INTERNATIONAL REALTY HOLDINGS LLC (07-69)**

Location: 7600 and 7650 SW 87 Avenue, Miami-Dade County, Florida (1.9 Acres)

The applicants are appealing the decision of Community Zoning Appeals Board #12, which denied without prejudice the following:

The applicants are requesting a zone change from semi-professional office district to residential/semi-professional office & apartments district, on this site. Also requesting to delete a covenant to remove a restriction requiring the property to be used only as an architect's office, florist, sod and nursery business, to allow the development of the site in accordance with the proposed zoning, and to permit an accompanying request(s).

2. MIAMI-DADE AVIATION DEPARTMENT (07-52)

Location: Between NW 36 Street & Perimeter Road, and between NW 42 Avenue & NW 72 Avenue, Miami-Dade County, Florida (3,300 Acres)

The applicant is requesting a Substantial Deviation Determination to a Development of Regional Impact (DRI) pursuant to Section 380.06(19)(c) of the Florida Statutes with respect to the following amendments and requests:

Modifications of conditions of previous resolutions to extend the build-out date and the termination date of the DRI for the Miami International Airport.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
