The list below contains zoning items which may be of interest to your immediate neighborhood.

**1. IGLESIA CRISTIANA EL BUEN SAMARITANO, INC. (06-277)**

Location: Lying east of SW 137 Avenue and between SW 258 Street and SW 260 Street, Miami-Dade County, Florida (6.7 Acres)

The applicant is appealing the decision of Community Zoning Appeals Board #15, which denied the following:  
The applicant is requesting a zone change from single-family residential district to interim district, and a special exception to permit a mausoleum, cemetery and ancillary chapel, on this site.

**2. MIAMI COMMUNITY CHARTER SCHOOL, INC. (08-164)**

Location: Lying on the southwest corner of SW 352 Street & SW 187 Avenue, Miami-Dade County, Florida (3.47 Acres more or less)

The applicant is requesting special exceptions to permit a charter school, and to permit a Senior High School within one mile of the urban development boundary. The applicant is also requesting to permit parking within 25' of an official right-of-way where it is not permitted, and to permit less street trees, less lot trees, and less shrubs than required, on this site.

**3. PALMETTO KTP L.L.C. (09-054)**

Location: The Northeast corner of NW 59 Avenue and NW 171 Street, Miami-Dade County, Florida (3.15 Acres)

The applicant is requesting a special exception to permit a charter school, and to permit accompanying request(s), on this site.

Plans are on file and may be examined in the Department of Planning & Zoning. Plans may be modified at public hearing.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
