1. <u>B & F MARINE, INC. (06-323)</u>

Location: Lying east of SW 72 Avenue, between SW 40 Street (Bird Road) and SW 41 Street, Miami-Dade County, Florida (1.03 Acres)

The applicant is appealing the decision of Community Zoning Appeals Board #12 which denied without prejudice the following:

The applicant is requesting a zone change from limited business district and single-family residential district to special business district. On plan "A" the applicant is requesting a greater lot coverage and floor area ratio than permitted, and to permit an accompanying request, on this site. Or in the alternative to the above requests: On plan "B" the applicant is requesting to permit setbacks to be less than required from property lines, a lot coverage and a floor area ratio to be greater than permitted. And with either group of requests, the applicant is requesting the following: To waive the required wall along the rear (south) property line where said lot lies across the street from residential (RU) zoned property.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
