1. THE DEPARTMENT OF PLANNING & ZONING (09-150)

Location: 11301 NW 12 street, Miami-Dade County, Florida (324.5 Acres)

The applicant is requesting modifications of conditions of a previous resolution(s) to allow the applicant to modify the build-out date and other dates within the development order of the Beacon Tradeport Development of Regional Impact.

2. MIAMI-DADE COUNTY HOMELESS TRUST (10-3)

Location: The Southeast corner of SW 127 Avenue and SW 280 Street, Miami-Dade County, Florida (75.5 Acres)

The applicant is requesting to modify conditions of a previously approved resolution and declaration of restrictions tying the site to a specific number of residential uses, to permit permanent residential units on the site through the submittal of revised plans through the governmental facility process.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
