1. SOUTHWEST DADE TRUST COMMUNITY DEVELOPMENT CORP. (11-089)

Location: Southeast Corner of SW 226 Terrace and SW 112 Avenue, Miami-Dade County, Florida
Size of property: 7 Acres

The applicant is requesting a special exception to permit the expansion of an existing charter school to include grades K-12 and a total of 1,012 students. In addition, the applicant is requesting modifications of conditions of previous resolutions, and of paragraphs of covenants to permit the applicant to submit new site plans showing more classrooms for the additional students and additional grades for the previously approved charter school with the previously approved church plans unchanged. Additionally, the applicant is requesting an accompanying request(s), on this site.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this board.
