1. MIAMI GARDENS COMMONS, LLC (11-077)

Location: 5901 Miami Gardens Drive, Miami-Dade County, Florida. Size of property: 2.95 Acres

The applicant is appealing the decision of Community Zoning Appeals Board #5, which denied with prejudice the following:

The applicant is requesting a zone change from IU-C (Industry-Controlled) to BU-2 (Business-Special), on this site. Additionally, the applicant is requesting non-use variances to permit less classroom space, less outdoor recreation space, and to permit (0) zero stacking spaces than is required, on this site. In addition, the applicant is requesting to waive a required 5' high masonry wall, and to permit more wall signs than is permitted, on this site.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this board.
