1. BAPTIST HOSPITAL OF MIAMI, INC. (13-106)

Location: 8900 North Kendall Drive, Miami-Dade County, Florida.

Size of property: 98.62 Acres.

The applicant is seeking to allow a zone change to RU-4A (Hotel/Apartment House District), to delete previously approved covenants and resolutions, and to permit an unusual use and special exception in order to expand the hospital use with accessory office buildings. Additionally, the applicant is seeking several variances regarding setbacks, temporary parking on gravel, certain parking spaces with a reduced back out dimensions, reduced spacing of the hospital use from residential (EU, RU-1 or RU-2) zone properties and for buildings to be spaced less than required from each other. The applicant is also seeking relief from the sign regulations.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this board.
