The list below contains zoning items which may be of interest to your immediate neighborhood.

1. **MILAGROS BORBON (07-276)**

Location: 20192 NW 79 Court, Miami-Dade County, Florida (70.18' X 105').

The applicant is requesting to permit a single-family residence and a covered terrace addition to the residence setbacks to be less than required from property lines, on this site.

2. **CARLOS M. SERRET (07-291)**

Location: 4800 NW 177 Street, Miami-Dade County, Florida (80' X 100').

The applicant is requesting to permit additions to a single-family residence setback to be less than required from property line, and to waive zoning regulations requiring that no fence or wall exceed 2.5' in height when located within the safe sight distance triangle; to permit a CBS wall higher than required within the safe sight distance triangle along the front property line.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
