Size of property: 95.34 Acres

The applicants are requesting a district boundary change from OPD (Office Park District), IU-1 (Light Industrial Manufacturing District) and IU-3 (Unlimited Industrial Manufacturing District) to IU-1 (Light Industrial Manufacturing District), on this site.
