1. FELIX RODRIGUEZ (14-143)

Location: Lying North of NW 154 Street, between NW 117 Avenue and NW 122 Avenue, Miami-Dade County, Florida.

Size of property: 34.15 Acres

The applicant is requesting to permit a commercial vehicle storage facility lot with less setbacks than required from the side street (South) property line, on this site.

2. BIP MINING LLC., BLACK ISLAND PARTNERSHIP & GO, INC. (15-008)

Location: Between NW 170 Street & NW 180 Street, between NW 107 Avenue & NW 117 Avenue, Miami-Dade County, Florida.

Size of property: 501 Acres

The applicants are requesting an unusual use to permit the expansion of a previously approved lake excavation on to additional property and the partial filling of the existing lake. Additionally, the applicants are requesting to modify a condition of a previously approved Resolution to allow the applicants to submit revise plans showing an expansion and partial filling of a previously approved lake.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this board.
