The list below contains zoning items which may be of interest to your immediate neighborhood.

1. MARILYN BARON, TRUSTEE (08-78)

Location: Lying west of NW 19 Court, approximately 190' north of NW 62 Street, Miami-Dade County, Florida (50' X 70')

The applicant is requesting to permit a parcel of land with less lot frontage and lot area than required, and to permit a single-family residence setback to be less than required from property line, on this site.

2. MARILYN BARON, TRUSTEE (08-81)

Location: Lying north of NW 62 Terrace, approximately 250' east of NW 19 Avenue, Miami-Dade County, Florida (40' X 90')

The applicant is requesting to permit a parcel of land with less lot frontage and lot area than required, a single-family residence setback to be less than required from property line, and to permit the residence with greater lot coverage than permitted, on this site.

3. PATRICK BURROWS (08-87)

Location: 335 NW 97 Street, Miami-Dade County, Florida (9,000 sq. ft.)

The applicant is requesting to permit a single-family residence and a swimming pool setbacks to be less than required from property lines, on this site.

4. EGLISE BAPTISTE D'EXPRESSION FRANCAISE, INC. (08-92)

Location: 8255 NW 2 Court, Miami-Dade County, Florida (2.1 Acres)

The applicant is requesting a modification and a deletion of conditions of a previous resolution to allow the applicant to submit a new site plan for a previously approved religious facility showing a new sanctuary and Sunday school building and to delete the condition for signage to allow a second and larger sign. Also requesting to permit an accompanying request(s), on this site.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
