The list below contains zoning items which may be of interest to your immediate neighborhood.

1. MILLER PLAZA, LTD. (07-53)

Location: 5801 SW 137 Avenue, Miami-Dade County, Florida (4.48 Acres).

The applicant is requesting a special exception to permit a car rental agency in the limited business (BU-1A) zoning district, to permit less trees than required within the greenbelt, and less parking spaces than required. Also requesting to permit an accompanying request(s), on this site.

2. MC DONALD'S CORPORATION AND T-MOBILE SOUTH LLC (07-270)

Location: 15295 SW 104 Street, Miami-Dade County, Florida (1.05 Acres).

The applicants are requesting a special exception to permit a camouflaged wireless supported service facility designed as a flag pole and ancillary equipment, and a modification of a condition of a previous resolution to allow the applicant to submit revised plans indicating a proposed camouflaged wireless supported service facility designed as a flag pole to be located on an existing restaurant site.

3. OSCAR A. AVILES (07-293)

Location: 4911 SW 139 Court, Miami-Dade County, Florida (30.05' X 81.16').

The applicant is requesting to permit a covered terrace addition setback to be less than required from property line, and to permit a patio area with less square footage than required, on this site.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications. Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
