#### **1. KENDALL INVESTORS 172, LLC. (13-090)**

Location: Southeast corner of SW 88 Street and 172 Avenue, Miami-Dade County, Florida.

Size of property: 42 Acres.

The applicant is requesting a District Boundary Change from BU-1A (Limited Business District) to RU-4L (Limited Apartment House District) and to delete a Covenant that prohibits the property to be developed with residential uses in order to develop the site with a 396 unit multi-family residential development. Additionally, the applicant is requesting to waive zoning regulations to permit SW 172 Avenue to curve East of the half section line.

#### **2. ERNESTO AMIEVA. (14-001)**

Location: 12930 SW 83 Street, Miami-Dade County, Florida.

Size of property: 83' x 103'

The applicant is requesting non-use variances to permit a carport addition to an existing single family residence with less setback than required from property line(s), and to permit a higher metal picket fence, on this site.
