The applicant is requesting a Non-Use Variance of zoning regulations to waive the required approval of the immediate adjacent townhouse owners in order to construct a wood trellis at the rear of the applicant's townhouse residence.

Location: Lying South of SW 64 Street, approximately 100'
West of SW 157 Place, Miami-Dade County, Florida.
Size of property: 2.24 Acres

The applicant is requesting a District Boundary Change from AU (Agricultural – Residential 5 Gross Acres) to RU-1MA (Modified Single-Family 5,000 sq. ft. Net), on this site.
