The list below contains zoning items which may be of interest to your immediate neighborhood.

1. PUBLIX SUPER MARKETS, INC. (07-260)

Location: 9111 South Dadeland Boulevard, Miami-Dade County, Florida (5.42 Acres)

The applicant is requesting to permit a liquor package store for the sale of alcoholic beverages on Sundays (not permitted except during the month of December), on this site.

2. DANIEL & BRIDGETTE GUIASOLA (07-266)

Location: 8960 SW 76 Street, Miami-Dade County, Florida
(125' X 180')

The applicants are requesting to permit a swimming pool setbacks to be less than required from property lines, on this site.

3. MICHAEL & MARIA MEDINA MILGRON (07-268)

Location: South of SW 112 Street, approximately 150' east of SW 82 Avenue, Miami-Dade County, Florida (149.77' X 163')

The applicants are requesting to permit a single-family residence setback to be less than required from property line, and to permit a greater lot coverage than permitted for a 2-story residence, on this site.

4. 5700 DEVELOPMENT LLC (07-275)

Location: Lying east of SW 57 Avenue, between SW 74 Street and SW 76 Street, Miami-Dade County, Florida (3.4 Acres)

The applicant is requesting to permit swimming pools setbacks to be less than required from property lines, on this site.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
