The list below contains zoning items which may be of interest to your immediate neighborhood.

1. **B & F MARINE, INC. (06-323)**

Location: Lying east of SW 72 Avenue, between SW 40 Street (Bird Road) and SW 41 Street, Miami-Dade County, Florida (1.03 Acres)

The applicant is requesting a zone change from limited business district and single-family residential district to special business district, to permit a greater lot coverage and a greater floor area ratio than permitted, and to permit accompanying requests, on this site.

2. **EDUARDO & MARLENE LLOSENT (07-110)**

Location: 7301 SW 80 Court, Miami-Dade County, Florida
(0.77 Acre)

The applicants are requesting to permit a barbeque and an addition to a single-family residence setbacks to be less than required from property lines, and to permit the barbeque to be spaced less than required from a gazebo, on this site.

3. **ABNER AND BETTY LAWTON (08-73)**

Location: 10305 SW 90 Street, Miami-Dade County, Florida (31,064 sq. ft.)

The applicants are requesting to permit a recreational vehicle with a greater length and height than permitted, on this site.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
