### I. Sunset Review

#### 1. MARIO & ANGELINA BUSTAMANTE (14-037)

Location: 7615 Ponce De Leon Road, Miami-Dade County, Florida.  
Size of property: 1.33 Acres

The applicants are requesting a District Boundary Change from EU-1 (Single-Family 1 Acres Estate) to EU-S (Single-Family Suburban Estate) district, and to permit two proposed lots each with less lot frontage than required, or in the alternative to the above, the applicants are requesting a Non-Use Variance to permit the lots with less lot frontage and less lot area of Acre Gross than is required, on this site.

#### 2. MARK H. KRAVETZ (14-089)

Location: 4840 SW 86 Terrace, Miami-Dade County, Florida.  
Size of property: 182.85' X 207.50'

The applicant is requesting Non-Use Variances to permit an existing carport addition to a Single-Family residence with Setback less than required from property line, and to permit a Greater Lot Coverage than permitted, on this site.
