1. **JULIO & MERCEDES RUIZ (07-102)**

Location: Lying north of SW 264 Street, approximately 833' west of SW 187 Avenue, Miami-Dade County, Florida
(1.15 Gross Acres)

The applicants are requesting to permit a parcel of land with less lot frontage and less lot area than required, on this site.

2. **MIGUEL BLANCO (07-312)**

Location: Lying east of SW 209 Avenue, approximately 400' north of SW 168 Street, Miami-Dade County, Florida
(1.26 Acres)

The applicant is requesting to permit a parcel of land for agricultural use with less lot frontage and less lot area than required, on this site.

3. **REGINA YOUNG (07-365)**

Location: 20225 SW 114 Court, Miami-Dade County, Florida (0.26 Acre)

The applicant is requesting to permit a family room, a carport, and a bedroom additions to a single-family residence setbacks to be less than required from property lines, on this site.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
