The list below contains zoning items which may be of interest to your immediate neighborhood.

1. **HARDIN HAMMOCK ESTATES ASSOC. & HAMMOCK GARDENS LLC (07-407)**

Location: Lying approximately 273' south of SW 224 Street & 100' east of theoretical SW 109 Avenue Court, Miami-Dade County, Florida (1.19 Acres)

The applicants are requesting a zone change from agricultural district and single-family modified residential district (RU-1Ma) to single-family modified residential district (RU-1Mb), and a deletion of a condition of a covenant to allow the applicant to delete a portion of a previously approved site plan to show portions of two previously approved lots to be included in two new lot configurations for a new residential development to the south.

2. **SCHOOL BOARD OF MIAMI-DADE COUNTY (08-4)**

Location: Lying north of SW 280 street, between SW Pennsylvania Avenue and SW Florida Avenue, Miami-Dade County, Florida (35.18 Acres)

The applicant is requesting to waive section line rights-of-way width zoning regulation requirements, to permit less dedication than required for the north half of SW 280 Street, on this site.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
