Eric Silva, Chief of Community Planning, began the meeting with introductions, a brief description of the charrette process, review of the meeting agenda and handouts.

Bob Schwarzriech, Section Supervisor for Planning Research, presented a summary of the Richmond Heights Demographic Profile (handout).

The study area boundary was discussed by the steering committee and community members present. The general boundaries for the study area are SW 117 Avenue and the Florida Turnpike to the west, SW 152 Street to the south and Lincoln Boulevard to the north and east. Following the discussion, steering committee member, Ed Hanna moved that the boundary should be as presented. The motion was seconded by steering committee member Anthony Brown and the committee unanimously approved the boundary for the study area. Mr. Hanna requested an additional charrette to address the area outside of the Downtown Core.

The steering committee discussed electing the Chair and Vice Chair, although it had been scheduled for the June meeting. Collectively it was decided to hold the elections to move the process forward. Mr. Hanna and James Brown were nominated for Chair. The vote was 6-2 in favor of Mr. Hanna. Mr. Anthony Brown was the only nominee for Vice Chair and was elected unanimously. Chairman Hanna stated there was need for a parliamentarian to keep order in the meetings and appointed Mr. James Brown to the position.

Chairman Hanna requested the charrette be a "Green Communities" charrette.
