Also, Article 10 to the Instruction to Bidders is being amended under addendum No. 1 to clarify the total contract duration to 760 calendar days. Liquidated damages are as per FDOT schedule. They can be found under Article 1.06, J. of the General Requirements (DTPW Division 1). DTPW has calculated the liquidated damages for this project to be approximately

\$4,769.00 per calendar day.
