QUESTION: 1) During the Pre-Bid Conference for the Bear Cut Project conducted this

morning Miami Dade County Representatives stated that the Contractor would not be required to procure any permits for the project. Can you

please be so kind as to confirm that statement?.

RESPONSE: 1) Based on discussions with the Department of Regulatory and Economic Resources (RER), South Florida Water Management District (SFWMD)

Resources (RER), South Florida Water Management District (SFWMD) and United States Coast Guard (USCG), a Class 1 permit is required. Permit was included in the Solicitation and Contract Documents under Section 4 Permits. However, should the contractor intend to use barges or marine vessels out of the staging area shown on RFI No.1, additional permits and/or coordination with Miami-Dade County RER will be required and is the responsibility of the contractor. The contractor is responsible for the environmental compliance for the monitoring of activity to protect mangroves, sea turtles, manatees, and other species. The RER environmental liaison for this project is Felix Alvarez, 305-372-5593 felix.alvarez@miamidade.gov. The contractor should refer to the Environmental Notes on Sheet S-6 in the plans for additional information. The final Temporary Traffic Control Plans will need approval from the Miami-Dade County Traffic Control Office, per Note 8, Sheet S-2. Aerial

and location of staging area was provided on RFI No.1.

RESPONSE: 2) The report including the survey and marking results, as well as projected

quantities submitted to the Engineer prior to the start of the concrete repair

work, do not need to be submitted in CAD.

QUESTION: 3)

The plans state "all costs associated with the temporary bracing/shoring system, included but not limited to shop drawings, material, erection, removal, storage, etc. shall be incidental to the concrete repairs". It all also requires temporary bracing/shoring system for any repair depths that exceed 12". There is no way to know how many repair depths will exceed 12". These temporary bracing/shoring systems are very costly. In lieu of having the bidders assume how many repair depths exceed 12", we suggest the Owner provide a separate pay item for temporary bracing/shoring system for repairs that exceed 12".

RESPONSE: 3)

The deepest delamination/spall encountered by visual inspection was 5". Should the deficiency worsen to a level exceeding 12" in depth during removal of bad concrete, it could become a structural issue. Depths exceeding 12" are not anticipated, based on previous inspection report from FDOT. At this time, a pay item creation is not warranted, and all cost will be covered by Pay Item 401-70-4.

QUESTION: 4)

The plans call for Removing and Replacing Existing Overlay along nosing as required. "See General Notes for Specifications." The general notes do not provide specifications, please provide the same.

RESPONSE: 4)

The contractor shall follow Section 02745 of the Miami Dade County Standards Specifications and Details for Design and Construction, which has been incorporated into Addendum No.3.

for the cost of installing Carbon Fiber Reinforced Polymer on beams?

RESPONSE: 8) Pay Item 450-82, Beam Repair, 194 LF, covers the CFRP beam wrapping

(80 LF as called out on Sheet S-22) and repair of spalled areas on the beams (114 LF per Sheet S-27). Epoxy injection is covered by pay items 400-134 (Epoxy Material For Crack Injection – Structures Rehab) and 400-135 (Epoxy Injection Of Cracks in Concrete Structure) cover the

Epoxy Injection.
