QUESTION: 1) Regarding Line Item #: 125-8 "BACKFILL TRENCH WITH SELECT FILL".

Can the contractor use existing fill as backfill for the trench?

RESPONSE: 1) The cost of backfill for trench on pipes and french drains is to be included

under the pipe and french drain pay items, as stated on the Constructions Specifications under unit of measurement of each item. Please refer to subarticles 430, L.1.a.2) and 443, G.1. Pay Item No. 125-8 is to be used only in the event an existing structure requires to be removed and not replaced. This pay item is contingent upon field conditions and may be increased,

decreased, or eliminated by the Engineer.
