Also, firms submitting as a Joint Venture must provide documentation for each entity participating in the Joint Venture to include the legal name of the companies participating in the Joint Venture as registered with the State of Florida together with copies of the Joint Venture agreement and statements of authority as submitted to the State of Florida Department of Professional Regulation Construction Industry Licensing Board (CILB). Please contact Vendor Registration Services, and they will guide you thru the process.

QUESTION: 2) Is there a checklist available for the required documents for bid submission?
